From April 23- May 3 the General Conference of the United Methodist Church will be meeting in North Carolina to make decision for the future of the Church as we do ever four years. Of course, there is many things special about this General Conference the first is that we did not have one four years ago because of COVID-19 and we have a special General Conference in 2019 to make decisions around the topic of Human Sexuality. The topics I want to talk about in this letter it what maybe expected at this 2024 General Conference (GC2024) and what it means to the Churches future.


So, first the GC2024 has not happened yet and so we do not know what the final outcome will be yet. Second there are multiple normal activities and decisions GC2024 will have to make like they do every time they meet, funding of programs, staffing questions, how we interact with other denominations. The third and probably what most people are interested in learning about is where the church is going on matters of Theology and Doctrine.

There is a lot of legislation coming before GC2024, there is legislation about reopening disaffiliation, and there is legislation about regionalization, Revising the Social principles, and Removal of harmful language about LGBTQ+ persons. If you are interested in a discussion about these things, please come to our Conversation on Sunday April 7 th at 2-4 in the Fellowship Hall. We will discuss what GC2024 is and some of the Legislation.

Like every four years this is a change in the life of the Church and as the delegates that represent united Methodist all around the work, I ask you to pray for them to have safe travels, good conversations, and that God will move throw them. Blessings

Do we, as the Tuscola United Methodist Church, nurture budding Christians in our midst whether they are children or adults? Do we have programs to help all of us become mature in our faith? We were created to do life together. Each of us needs a safe place to ask our questions, make new friends, and grow in our faith. Meeting information from February and March has been consolidated below for Trustees and Finance since they meet monthly.

**Trustees** decided there should be two additional phones installed at opposite ends of the building for emergency purposes. Since the phone system is now voice over IP (VoIP), the only two phones currently installed are in the office area which is locked after hours. A motion was passed for All-Pro to install a tankless water heater in the parsonage at a cost of \$3755. This work has been completed. Our insurance premium with Church Mutual has risen from \$20,000 to \$29,000 per year due to the wind and hail claims for the roofs and the claim recently settled from the broken water pipe in the parsonage upstairs bathroom in 2020. Therefore, Trustees agreed with the Finance committee to change the insurance premium payment from yearly to monthly to help with cash flow. Our insurance deductible has risen from \$5000 to \$10,000. A motion was made to sell the staging that had been used by our choir to Decatur Eisenhower

High School for which we received \$300. All memorials totaling less than \$1000 will now be used at the Trustees' discretion. It was decided not to erect a fence around the playground equipment for the time being. Four external church doors have been repaired by Bacon and Van Buskirk.

The **Finance** committee meeting in February was canceled. In their March meeting, the committee discussed the possibility of creating a bookkeeper-type position to handle payroll and financial reports. SPRC would be responsible for creating this position should it be deemed necessary.

Committee and team reports, including Finance and Trustee information reported above, were presented to the **Church Council** at their meeting on March 18.

The Lay Employee Policy Manual has been completed and **SPRC** members were asked to give it one final read and send any issues to Chair Cheryl Bozarth. The plan is to have it implemented by the end of April.


**Christian Justice** team has two programs scheduled related to the topic of the school to prison pipeline. A video followed by discussion is scheduled for April 21 from 2-4 PM. A speaker is scheduled for May 19. The Worship team is working on the 2024 list for liturgist, greeter, usher, soundboard, and communion stewards. The **United Women in Faith** Mother-Daughter banquet will be held on April 18 at 6:30 PM.

**SAM pantry** statistics show that 30 more families were served in January and 16 less in February as compared to last year. The pantry coordinator position has not yet been filled.

In the **Pastor's report**, Pastor Bennett announced that the church office hours have been changed to Monday-Friday from 9:00 AM to 4:00 PM.

The **Church Council** meeting ended with a discussion of the Simplified Accountability Structure (SAS). Former pastor Terri Haas introduced this concept in 2021 and implemented parts of it when the committees such as Worship, Christian Justice and Congregational Care were formed. Pastor Bennett stated that he believes TUMC would benefit by using the SAS model. A motion was made and passed authorizing Pastor Bennett to begin the steps toward full implementation. The next regular meeting of Church Council will be May 20, 2024 at 6:00PM in the Fellowship Hall.
